CODE OF CONDUCT Motorcycle Scavenger Hunt

RELEASE OF LIABILITY, ASSUMPTION OF RISK, WAIVER, AND INDEMNITY AGREEMENT

Organizer: EMS RoadDocs RC

In consideration of being permitted to participate in the Motorcycle Scavenger Hunt ("Event") organized and hosted by EMS RoadDocs RC ("Organizer") and anyone who is associated with the EMS RoadDocs RC, I agree to the following terms:

1. Voluntary Participation & Acknowledgment
 - a. I voluntarily choose to participate in this self-guided, unsupervised motorcycle event and acknowledge that I have read and agree to the Official Rules.
2. Description of Activities
 - a. The Event consists of self-directed motorcycle travel to public locations, photo submissions, and mileage documentation.
3. Assumption of Risk
 - a. Motorcycle riding involves inherent risks including traffic accidents, weather, road hazards, mechanical failures, and the actions of others. I knowingly assume all risks.
4. Compliance with Laws and Safety
 - a. I agree to obey all traffic laws and safety requirements. Unsafe behavior may result in disqualification.
5. Release and Waiver of Claims
 - a. I release EMS RoadDocs RC, its officers, members, volunteers, and affiliates from any liability arising from participation, including negligence, to the fullest extent permitted by law.
6. Indemnification
 - a. I agree to indemnify and hold harmless EMS RoadDocs RC from any claims arising from my participation.
7. Photo, Video, and Documentation
 - a. I grant EMS RoadDocs RC permission to use submitted photos and documentation for promotion and administration.
8. Participant ID & Proof Requirements
 - a. I acknowledge ID display requirements and understand digitally added IDs will invalidate submissions.
9. Payments; No Refunds
 - a. Entry fees are non-refundable. Participation requires payment and execution of this waiver.

10. Duplicate Submissions & Judging
 - a. Duplicate submissions are prohibited and judge decisions are final.
11. Tie-Breaker & Mileage Verification
 - a. Mileage may be used as a tiebreaker and requires documented proof.
12. Minors
 - a. Parents or guardians accept responsibility for minor participants.
13. Medical Treatment Authorization
 - a. I authorize emergency medical treatment if necessary.
14. Health & Public Safety
 - a. I agree to comply with any safety protocols.
15. Insurance
 - a. I acknowledge the Organizer does not provide insurance.
16. Severability
 - a. If any portion of this agreement is invalid, the remainder remains enforceable.
17. Entire Agreement
 - a. This document constitutes the entire agreement between the parties.
18. Governing Law
 - a. This agreement is governed by the laws of the applicable state.
19. Electronic Signature
 - a. Electronic signatures are valid and binding.
20. Acknowledgment
 - a. I understand I am waiving legal rights by signing this agreement.
